I agree to the following Terms and Conditions for Easyriders Social Motorcycle Club's Charity Ride on November 22, 2025:

- Easyriders Social Motorcycle Club is the organiser of this Event. CareFlight has been named as fundraising beneficiary but is not an Event organiser.
- Any matter concerning damage, liability, costs, proceedings, demands, physical or psychological harm, injury or death associated with this Event, will be investigated, managed and resolved between Easyriders Social Motorcycle Club and the relevant participants.
- CareFlight takes no responsibility for damage, liability, costs, proceedings, demands, physical or psychological harm, injury or death associated with this event.
- It is Easyriders Social Motorcycle Club's responsibility to ensure:
  - Any participant driving a motorcycle during the Event holds a current motorcycle rider's licence issued by an Australian state or territory or a recognised current international rider's licence for the class of motorcycle which the participant rides in the Event and the participant has sufficient experience and is not under probation or subject to disqualification or suspension for any reason.
  - Any participant driving a motor vehicle other than a motorcycle during the Event holds a current licence issued by an Australian state or territory or a recognised current international licence for the class of motor vehicle which the participant drives in the Event and the participant has sufficient experience and is not under probation or subject to disqualification or suspension for any reason.
  - Any participant driving any vehicle in this Event will have the relevant and necessary registration and insurance to ensure compliance with relevant laws and legislation and provide coverage in the event of accident or incident.
  - All participants are in appropriate physical or psychological condition to participate in this Event.
  - All participants agree not to participate under the influence of alcohol or illicit substances.
  - All participants comply with relevant road rules, legislation, and safety guidelines.
- All information provided by participants via this portal is accurate and correct. No participant may submit under a false name or impersonate another during registration, or in relation to the event generally.
- All participants must be aged 18 or over.
- No participant may submit on behalf of another participant, except for a rider who includes the name of a pillion travelling on the same motorcycle in the comments box at the end of the donation form. Any rider who lists the name of a pillion as part of their submission certifies that:
  - They are authorised to do so.
  - The other participant for whom you are authorised to list as participating has read, and has agreed to and is bound by, these terms and conditions.
  - The details provided in relation to the other participant are true and correct.
- CareFlight may retain participants' contact details and contact them in future.
